JOINT ADMINISTRATIVE REGULATION
No.10.2110-2/MFDP/MOT/15 MAY 2015

TO : VEHICLE OPERATORS, VEHICLE OWNERS AND THE GENERAL PUBLIC

SUBJECT : OFFICIAL FEE STRUCTURE FOR VEHICLE LICENSING AND REGISTRATION

DATE : 15 MAY 2015

1. GENERAL RULE

The Ministry of Finance & Development Planning (MFDP) is responsible amongst other things, for the formulation of fiscal policies to govern taxation pursuant to the Revenue Code of the Republic of Liberia, while the Ministry of Transport is responsible amongst other things, for the administration, regulation and issuance of license and registration fee (s) for all types of vehicles in the Republic of Liberia, pursuant to the Motor Vehicle Policy of 2009.

In keeping with section 14247 of the Liberia Revenue Code, the Minister has the power to issue regulations as necessary from time to time to give effect to the code and further the purpose of carrying into effect any of its provisions.

2. LEGAL BASIS

Section 2110 of the Consolidated Tax Amendment Act of Liberia; Government Agency Fees- Ministry of Transport-Annual Fees stipulates that "The fees for the following services/activities of the Ministry of Transport shall be by regulation, prescribed by the Minister of Transport in consultation with the Minister of Finance & Development Planning, and shall be regularly assessed by the Ministry of Transport and be paid regularly to the Liberia Revenue Authority for deposit into the account of the Government."

3. PURPOSE

This Administrative Regulation is an amendment to the Ministry of Transport Regulations Published December 2009 to govern the Administration and Issuance of Vehicle Licensing and Registration, promulgating the official fee structure for Vehicle Licensing and Registration, in the Republic of Liberia. Pursuant to said Regulation.

4. PROCEDURE NOTICE

This Administrative Regulation hereby institutes the empowerment of the Ministry of Transport to regulate and assess the new Vehicle Licensing and Registration fee from any vehicle owner/ operator /applicant, who then proceeds to the collection window at the Liberia Revenue Authority (LRA) for the payment of said fee and subsequent deposit into the consolidated fund in accordance with section 7 of the Revenue Code of Liberia, prior to the issuance of said Vehicle Licensing and Registration by MOT in keeping with MOT Vehicle Licensing and Registration Regulations, aforementioned.

5. PUBLIC NOTICE


The Government of Liberia through the Ministry of Finance and Development Planning and Ministry of Transport hereby announce the new fee for Vehicle Licensing and Registration as follow:
