The Ministry of Transport (MOT) was established by an act of legislature on August 25, 1987 to administer the Transport, Insurance and Maritime regulations of Liberia. These include the oversight responsibility for execution of policies relating to land, sea and air transport services operating within the Republic of Liberia.
